- ii. Volunteers have given 76 hours to help 23 clients in the last month.
- iii. Need draft presentation by 12/12/19.

2. New business:

- a.** APS caseworkers are now working from home.
- b.** Need a means for APS to locate homeless clients.
- c.** Silver key is now an approved Medicaid provider for mental health services.
- d.** CCERAP is transitioning from CNDC to a new support organization. Steering Committee members are needed.
- e.** It was recommended we do a presentation on PPEAC to the SRC in June 2020.
- f.** CSFD initiated a program to assist aging in place and has a designated navigator. All referrals come from the fire line but address needs more acuity than other programs at Community and Public Health
