1. Welcome and Introductions

2. Subcommittee 2020 accomplishments, 2021 plans.

a. Education and Outreach: Detective Chuck shared that in 2020 with COVID there were 12 classes with a total of 500 attendees. A typical year is 50 presentations with over 900 attendees. As of January 14, they had already done a program for the UCCS Gero-psych program. Dedra Worley with CSPD will take over Steve Worley's work with the DOJ.

b. Elder Shelter Program: Chrissy Swanson reported 2019 numbers served were 80, this year only 7. She is only aware of SAVA placements so committee needs to get more data. Down to 11 communities from 14. Vibrance had 2 from DOC to add to the numbers. This verifies the need for a coordinator.

c. GVAP: Ann McKenzie shared March had 2 classes, 8 participants, 6 committed to volunteer. With the State of Emergency, nothing could happen. 4-6 volunteers are still interested. Devon, Christina and Tammra are all interested in using them. Future trainings are on hold.

d. Pikes Peak Elder Justice Center – nonprofit formation: Melissa Marts reported the 501c3 paperwork is filed with the IRS. State EIN has been granted. Numerous funding sources have been identified. Hope to have first funding available in April.
