

# **Not One More Child Meeting Notes**

## **March 18, 2019**

### **Sallie Clark Farewell**

- Sallie Clark is serving as State Director for USDA Rural Development in Colorado, a presidential appointment.
- Former Commissioner Sallie Clark thanked everyone for their involvement, efforts and engagement in helping protect the most vulnerable in El Paso County.
- Not One More Child shows how much the community is dedicated to protecting children.
- She will still be involved in our region; rural development and opiate initiatives impact the community. The USDA continues programs including loans and grants to help communities.

### **Commissioner Cami Bremer Welcome**

- Elected official, Commissioner Bremer, joins District Attorney Dan May for Not One More Child.
- Commissioner Bremer is excited to work with community partners as we continue efforts to decrease child abuse and neglect in our region.

### **Differential Response (DR) and Child Protection (Jill Calvert, Children, Youth and Family Services Director, Department of Human Services)**

- Differential Response (DR) is an opportunity for child protection case workers to engage families differently.
- Child protection casework as a profession is relatively young – only 75 years or so.
- On average 20 percent of the child protection cases are considered severe; about 80 percent are for neglect or lesser abuse.
- Most DHS cases are civil, not criminal.
- The traditional approach makes it more challenging to engage families
- Background
  - Legislation was written to allow a change in how Human Services departments handled child protection; the focus is on finding the best way to improve the situation.
  - State model; El Paso County spent about a year setting up the structure and making changes to foster the communication changes necessary to accommodate the change in system
  - State will audit and check on structure as well as social work practices.
  - Additional training and coaching is built into the system
- Differential Response (DR)
  - First priority is child safety
  - “Right-size” the response by DHS

- Shift in services
- Families have a role in determining support
- Enhanced screening: Hotline call takers ask additional questions to develop a global view of the family and situation
- Focus on appropriate parenting and away from “all or nothing” approach
- Dual Track Response System (FAR & HRA)
  - Family Assessment Response (FAR) for low to moderate risk referrals; What is the situation?
  - High Risk Assessment (HRA) – Traditional investigative approach; Did this happen?
- Don’t anticipate a decrease in cases, but may yield a decreased in court cases
- Criteria will be/is developed for allegations to continue to be assessed in the traditional manner, for example sexual abuse and/or severe physical abuse
- Expectation for more checks and more follow-up to ensure safety demonstrated over time
- RED Teams (Research, Evaluate, Direct) will still decide if reports meet criteria for involvement. The teams meet at least eight times a day, and involve staff at several levels in the decision-making process.
- DHS is moving towards having a multidisciplinary team review cases, which utilizes the strengths in the profession.
- Facilitated Family Meetings are not new to El Paso County. These meetings will bring in community services as well as family members to better make connections and facilitate assistance.
- Improving supports
  - DR opens to door for front-loaded services, more flexible for helping to strengthen families.
  - Support planning builds on supports and strengths in place for families so when DHS steps out, families can sustain improvement.
  - Medicaid is a key component; families and children can maintain medical care without DHS involvement
- One expectation is the perception of DHS will change, so families will call in concerns of neglect/abuse before situations reach critical levels.
- DHS will be working even more closely with community partners to connect families to supports and services.

**Child Abuse Prevention Month (Julie Krow, Department of Human Services Executive Director)**

- April is Child Abuse Prevention Month (CAP Month).
- DHS partnered with the Colorado Springs Conservatory.
- Goal is to focus Child Abuse Prevention Month on “what can we do to help the children in El Paso County.”
- CAP Month used to highlight child safety and the ongoing need for foster and adoptive families. Not everyone can be a home for youth, but everyone can do something.

- El Paso County has a high number of children in residential and congregate care and we want to bring them “home.”
- Window clings promoting CAP Month messaging.
- Magnets with “How to Choose a Safe Caregiver” – Fort Carson will sponsor.
- Proclamations read in municipalities across the region; Colorado Springs Conservatory children and musicians performed across the County.
- The NOMC community cards were shared at multiple events, and continue to be shared in the community to share safe messaging.
